The offer shall be addressed to the Jt Chief controller of Explosives, Petroleum and Explosives Safety Organisation, 5th Floor, CGO Complex, CBD Belapur, Navi Mumbai (Maharashtra).

GENERAL CONDITIONS

- (1) The Technical and Commercial Bids are to be furnished separately. The sealed covers containing Technical bids only will be opened in the first instance in the presence of Firm's representative. In case Technical documents are not found in order as per the requirements, the bid will be rejected and the Envelope "Commercial Bid" shall not be opened.
- (2) **Validity:** The price quoted must be firm during the tenure of the contract and offer must remain open for acceptance minimum upto 180 days from the date of opening the tender. Offer with a validity of less than 180 days will be liable for rejection without any further reference.
- (3) EMD (Earnest Money Deposit) should be furnished for an amount of Rs.5,000/-. Earnest money should be paid in the form of a Demand Draft drawn on a nationalized bank in the name of Joint Chief Controller of Explosives, West Circle, Mumbai payable at Navi Mumbai. The demand draft should be kept in a sealed separate cover superscribing E.M.D. without mentioning amount. Quotations received without EMD will be summarily rejected. Tenderer will not be allowed to withdraw his offer. EMD shall be forfeited if tenderer fails to honour the contract.
- 4) **Late Receipt of the Offers:** Late/delayed offers, fax offers/messages, telegraphic offers and incomplete offers are liable to be rejected. Any late/delayed tender received will not be opened.
- (5) Each page of the offer is to be signed and stamped.

- (6) The tender will be accepted or rejected on recommendation of committee appointed by the Jt. Chief Controller of Explosives, West Circle, Mumbai for this purpose. The Jt. Chief controller of Explosives, Mumbai reserves the rights in accepting or rejecting any tender without assigning any reason whatsoever.
- (7) **Payment terms:** The payment will be released only after commissioning of L.A.N on installing the same in the O/o. Jt. Chief Controller of Explosives, West Circle, Mumbai. No advance payment will be made.
- (8) The rates should be quoted in Indian Rupees. The rate must be written in figure as well as in words. The alterations in the rates should be signed in ink otherwise the quotation/tender will not be accepted.
- (9) Incomplete bids, conditional bids, bids not conforming to the terms and conditions are liable for rejection.
- (10) Necessary networking components are to be supplied by the firm.**
- (11) The delivery, installation and commissioning of the L.A.N. shall be **done before 25/08/2009** and qualifying bidder shall submit the acceptance of order **within three days from the date of receipt of order**. In case, acceptance of order from the bidder within stipulated period is not furnished, the other bidder (at L-2) may be given offer by the tender committee.
- (12) Warranty of L.A.N **shall be three years** from the date of commissioning of L.A.N.
- (13) The bidder should be authorized supplier and service/maintenance provider of the L.A.N. systems.
- (14) If the performance of L.A.N. components are not found satisfactory during warranty period, the Organisation reserves the right to forfeit the entire security deposit.
- (15) Turnover of the company should be more than 10 Lacs.

TECHNICAL BID

Technical bid shall be organized and submitted as per following sequence:

1. Table of contents (List of documents enclosed with page nos.)
2. Technical specification and brochures of the Networking components.

3. Documentary proof in support of their authorized dealership/distributorship of reputed L.A.N. components.
4. Documentary proof in support of their supplying, installing and commissioning the L.A.N. system in Mumbai/Navi Mumbai/Thane.
5. Company profile and details of support service infrastructure.
6. The bidder should be financially sound. The annual financial statement/income tax clearance certificates etc. for last 3 years, as documentary evidence in this respect are to be provided.
7. Undertaking to the effect that the Firm shall provide after sales service during the warranty period by themselves and not by their franchisees or awarding sub-contracts to any other party.
8. Undertaking to the effect that the Firm shall provide maintenance and repair services on holidays in case of emergency or as per the requirement of the Organization during the warranty period.
9. Undertaking to the effect that the firm will be ready for down time penalty during the warranty period which is equivalent to Rs.200/- per working day.
10. Any other required information/certificates etc.
11. Turnover certificate.
12. Undertaking to the effect that all conditions mentioned under the Head general conditions will be agreed to.

Commercial Bid

Commercial bid should be submitted in a separate sealed cover. The price should be inclusive of all taxes, delivery charges, installation charges and commissioning charges. The commercial bid must reflect the details of L.A.N. components along with the model number of L.A.N. components of the company meeting the technical specification requirement of this office.

The tender bids should be submitted as follows: -

- (a) Technical bid in a separate sealed cover, containing documents satisfying all eligibility conditions. This envelope should be superscripted“ TECHNICAL BID”.
- (b) Commercial bid, should be submitted in a separate sealed cover and should be superscripted “COMMERCIAL BID”.
- © A third cover containing D.D. of the EMD and should be superscripted “EMD”.
- (d) The outer cover in which these sealed covers are placed should be addressed to the ‘Jt.Chief Controller of Explosives’, A-1 & A-2 Wing, 5th floor,C.G.O. Complex, CBD Belapur, Navi Mumbai indicating the Tender for supply, installation & commissioning of L.A.N. system.
- (e) The sealed cover containing technical Bid will be opened in the first instance in the presence of an authorized representative of the bidder. Only one representative per tenderer would be permitted to be present at the time of opening the technical bid. Firms will be short listed by a duly constituted Tender Evaluation Committee (TEC), on the basis of technical parameters.
