Sub: Reduction in compliance burden – introduction of third party for prototype and batchwise inspection of cylinders, valve & regulators – reg.

In pursuance of Government initiatives for ease of doing business and reduction in compliance burden, PESO was considering introduction of third party inspection agencies for various statutory inspection for manufacture of cylinders, valves and regulators. A committee of PESO constituted for the purpose recommended introduction of TPIA for prototype & batchwise inspection of cylinders, valves and regulators.

Considering the recommendations of the committee, Ministry of Commerce & Industry, Department for Promotion of Industry & Internal Trade, New Delhi has conveyed concurrence vide letter No. P-13018/91/2020-EXPLOSIVE dated 23.03.2021.

Accordingly, it is to inform to all concerned that manufacturing of cylinders, valve and regulators of any standard made either of Indian or International specification & accepted by the Chief Controller of Explosives, may be inspected by third party inspection agencies recognized by Chief Controller of Explosives for prototype as well as batch-wise inspection. A list of recognized third party agencies is enclosed.

PESO however reserves it right to involve itself along with TPIAs in any such joint inspections.

This is issued in pursuance of Rule 66 (read with A.1(a), B.1 of schedule I) of Gas Cylinders Rules, 2016.
