Sub:- Special drive for increasing the number of competent persons under the SMPV Rules – regarding

Sir,

Govt. of India is promoting Make in India and Atmanirbhar Bharat vision and policies for the promotion of industries in the country. In this regard it is being considered to promote the cause of ease of doing business through focus on the reduction in regulatory compliance burden while ensuring the safe industrial practices to avoid industrial accidents. Periodic testing of pressure vessels and safety Relief Valves are regulatory requirements which are undertaken by competent persons recognized by PESO.

LIN/LOX/LAR manufacturers normally have multiple storage vessels licensed under SMPV Rules and also own several road tankers for transportation which require periodic testing Rule 18 & 19 of SMPV(U) Rules.

To address the shortage of competent persons, I request you to encourage all eligible officers of your organisation to approach PESO, HQ for enrolling for recognition as competent persons under Rule 18 & 19 of SMPV(U) Rules for catering your own requirements related to compliance of safety. This shall greatly reduce expenditure incurred by your company against engaging competent persons from the public as also reduce the time taken to ensure compliance.
