**Expression of Interest for empanelling Third-Party Inspecting Agency under
Gas Cylinders Rules, 2016**

PESO intends to empanel Third-Party Inspection Agencies (TPIA) of National & International repute to perform design appraisal, witnessing proto type testing and lot inspection of Gas Cylinders, Valves and Regulators manufactured under the Gas Cylinders Rules, 2016. Organisations fulfilling following minimum eligibility criteria may submit their applications for empanelment and recognition as Third-Party Inspection Agencies (TPIA).

(A) Eligibility Criteria:

1. Participating TPIA shall be a professional organisation registered & located in India with minimum two or more persons.
2. Minimum experience of ten years in carrying out design appraisal, witnessing proto type testing / lot inspection during manufacturing of Gas Cylinders, Regulators, Valves, Self Closing Valves, Multi Function Valves, Safety Relief Valves and other fittings under the Gas Cylinders Rules, 2016.
3. The organisation shall not be blacklisted or debarred by any Government Department or Organisation. An undertaking in this regard to be submitted.

(B) Process of Selection:

1. All the applications of TPIA shall be assessed for their eligibility as per the provisions of the Acts & Rules.
2. Applicants will submit their application in a prescribed proforma (Details attached).
3. Based on the documentary evidence on the expertise of the TPIA in specific fields, the recognition of TPIA will be considered under specific provisions of the rules.

(C) Important Note:

1. The work of TPIA shall not be outsourced.
2. At any stage of selection if PESO finds that any of the information submitted by applicant is false, his application will be rejected.
3. PESO reserves the right, at its sole discretion, to cancel, terminate, and suspend the candidature of TPIA at any point of time if TPIA is unable to perform their duties satisfactorily.
4. The decision of PESO will be final and binding with regard to selection of TPIA.
