Petroleum & Explosives Safety Organization (PESO) has already launched facilities of e-Filing of applications and e-Payment gateway to provide hassle free and value added online services to all the license holders under Gas Cylinders Rules, 2016 w.e.f 12<sup>th</sup> July, 2016 and under Static & Mobile Pressure Vessels (Unfired) Rules, 2016 w.e.f 15<sup>th</sup> April, 2017.

The following guidelines may please be followed for availing the said facilities:

1. The e-Filing application facility can be accessed by the license holder through PESO’s website “<http://www.peso.gov.in/index.aspx>” having link “Apply Online →Petroleum/Gas Cylinders/SMPV(U) Rules Application Login”
2. To avail these facilities of e- Filing and e-Payment, it is essential for the license holder to register through the “New User” link on the login page and create a profile with user-id and password, to start with.

3. The license holder can add all his licenses in his profile (portfolio) and make use of e-Payment of fees facility as mentioned above.
4. e-Payment facility for all applications and e-Filing under Petroleum Rules, 2002, Gas Cylinders Rules, 2016 and Calcium Carbide Rules 1987 has already been launched and is operational since 12<sup>th</sup> July 2016.
