Sub: Request for relaxation in explosives transactions, licensing and returns during COVID-19 outbreak - reg.

Sir,

Please refer to your letter No. EMWA/RAR/PESOWFH-9/EML dated 08/04/2020.

With reference to your request for relaxation in explosive transactions, licensing and returns, etc following comments are offered:

1. The explosives manufactures may bring back their consignments in transit stranded due to lockdown to the point of dispatch. The approximate reach date in the RE-12 (Pass issued by consignor for transport of consignment of explosives) returns forms which are already issued may be extended as per request by respective licensing authorities in co-ordination with NIC.
2. Excess storage due to return of consignments to the point of dispatch or any other reason may be permitted as per Rule 74 of the Explosives Rules, 2008. Permission of the licensing authority may not be required during the lockdown period; however fees as prescribed under Part 2 of Schedule IV shall be submitted as per Rule 74(2) of the Explosives Rules, 2008.
3. PESO has already intimated to DPIIT for allowing only one armed guard to accompany the explosive van instead of two armed guard.

4. The monthly returns and quarterly returns of the explosives transactions for the month of March-2020 and January-March 2020 quarter respectively may be submitted up to 30th April, 2020.
5. The explosive manufacturers may submit an undertaking that the export container meets with the specifications of PESO with respect to license in Form LE-7 of the Explosives Rules, 2008. The endorsement of the license will be done by licensing authority may be waived off without inspection till the end of the lock down period.
